Statement of responsibilities of the Board

The Board are responsible for preparing the annual report and the financial statements in accordance with applicable law and regulations.

Opinion

We have audited the financial statements of ICOF Community Capital Limited (the 'society') for the year ended 31 December 2019 which comprise the profit and loss account, balance sheet, statement of changes in equity and the related notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 Section 1A: The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

1. Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with FRS 102 Section 1A - The Financial Reporting Standard applicable in the UK and Republic of Ireland and the Co-operative and Community Benefit Societies Act 2014.

Going concern

The accounts have been prepared on the assumption that the society is able to continue as a going concern. However, the COVID-19 pandemic is likely to have a profound impact on the global economy and may in turn affect the society. The officers have considered the impact of this issue on the society's current and future financial position. The society held a cash balance of £328,142 at 31 December 2019, and the officers consider that the society has sufficient cash reserves to continue as a going concern for a period of at least 12 months from the date on which these financial statements are approved.

Turnover

Turnover represents the amount derived from interest and fees on loans falling within the society's activities.

Fixed asset investments

Fixed asset investments comprise investments in co-operative share capital and are stated at historic cost less impairment.

Investments in non-equity preference share capital are recognised initially at cost and subsequently at amortised cost using the effective interest method, less any impairment.

Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less impairment losses for bad or doubtful debts except where the effect of discounting would be immaterial. In such cases, the receivables are stated at cost less impairment losses for bad or doubtful debts.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

Taxation

Taxation represents the sum of tax currently payable and deferred tax.

The society's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

1. Accounting policies (continued)

Taxation (continued)

Deferred tax is recognised on all timing differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset released, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

2. Turnover

Turnover represents net invoiced sales of goods, excluding Value Added Tax.

Turnover attributable to geographical markets outside the United Kingdom amounted to 0% (2018 - 0%).

The loan is an unsecured loan for £97,000 with Industrial Common Ownership Finance Limited, which is repayable in full in December 2022. Interest is payable at the base rate (currently 0.75%). The loan is stated in the accounts at amortised cost at a rate of 6%. 11. Related party transactions

ICOF Community Capital Limited shares common directors with Industrial Common Ownership Finance Limited and Industrial Common Ownership Fund Plc.

ICOF Community Capital Limited has a £97,000 loan (2018: £97,000) from Industrial Common Ownership Finance Limited. During the year interest of £728 (2018: £606) was paid on the loan.

ICOF Community Capital Limited has an investment of £97,000 non-equity preference shares (2018: £97,000) in Industrial Common Ownership Fund Plc. These became redeemable in September 2017. ICOF Community Capital Limited has waived its dividends on the shares going forward (2018: nil).

During the year ICOF Community Capital Limited was charged a management fee of £19,393 (2018: £19,215) by Industrial Common Ownership Finance Limited. These charges were made on normal commercial terms.
