I also serve as a Trustee of the Co-operative College and, in my day job, as Operations Manager and a worker-director of Campaign Against Arms Trade.

CCF has weathered the storm of the pandemic, providing tailored support to the wide range of co-operatives and community businesses that make up our lending portfolio, and as business picks up again, I'm proud that we have signed up to the Diversity Forum manifesto and partnered with Co-ops UK to deliver the Flexible Finance for Recovery fund with the aim of ensuring that we spread the co-operative model to all communities in the UK.

With your support, I would be honoured to serve another term as a director of the Cooperative and Community Finance group and to continue to ensure that we serve and support the growth of the co-operative economy.

- Started with NatWest Bank, working at offices in and around Manchester.
- 1981 completed my banking exams (ACIB)
- 1989 moved to TSB as part of a business lending team aligned with the Bank's strategy to move away from a savings bank
- 1991 moved to TSB's new head office to lead a commercial lending team.
- 1995 TSB merged with Lloyds. Played a major role in establishing a credit scoring for small businesses to replace traditional analysis.
- 2001 Rolled out a new commercial credit risk rating system based on financial and non-financial analysis, ensuring a consistent approach to risk across the network and focused internal lending and monitoring processes.

#### **Sherston Post Office Stores**

- November 2004 purchased at Sherston Post Office &Stores, Wiltshire.
